In the case of motels, this includes off-street parking facilities, but not necessarily meal services. The industry is detailed in both value and volume terms.
- The Taiwanese hotels & motels industry recorded revenues of \$1.2 billion in 2023, representing a negative compound annual growth rate (CAGR) of 2.1% between 2018 and 2023.
- The number of establishments in the industry declined with a negative CAGR of 0.6% between 2018 and 2023, reaching a total of 124 in 2023.
- The growing travel and tourism expenditure is a key driver of revenue in the hotels & motels industry. According to the World Travel & Tourism Council (WTTC), the total travel and tourism spending in Taiwan reached \$73.3 billion in 2023, reflecting a 105.9% increase from 2022.
