- The growing travel and tourism expenditure is a key driver of revenue in the hotels & motels industry. According to the World Travel & Tourism Council (WTTC), the total travel and tourism spending in the Netherlands reached \$43.3 billion in 2023, reflecting a 14.5% increase from 2022.
