- The Russian IT hardware market had total revenues of \$4.6 billion in 2023, representing a compound annual growth rate (CAGR) of 4.9% between 2018 and 2023.
- The client computing hardware segment accounted for the market's largest proportion in 2023, with total revenues of \$2.2 billion, equivalent to 48.4% of the market's overall value.
- The government has encouraged domestic production to lessen reliance on foreign imports, notably in high-tech industries such as servers, computers, and related components. This trend toward self-reliance is driving demand for domestically produced IT hardware.
