- The Australian metals & mining industry recorded revenues of \$213,944.8 million in 2023, representing a compound annual growth rate (CAGR) of 9.5% between 2018 and 2023.

- The production volumes declined with a negative CAGR of 0.1% between 2018 and 2023, to reach a total of 1,489,098.7 thousand tonnes in 2023.

- The decline in metal & mining in Australia was primarily attributed to a decrease in demand for base metals. According to GlobalData, base metal production fell by 3.3% in 2023.
