- The Colombian metals & mining industry recorded revenues of \$11,536.5 million in 2023, representing a compound annual growth rate (CAGR) of 3.6% between 2018 and 2023.
- The production volumes declined with a negative CAGR of 9.6% between 2018 and 2023, to reach a total of 52,123.9 thousand tonnes in 2023.
- In 2023, the Colombian metals & mining industry experienced negative growth due to a decline in demand for coal production. According to GlobalData, coal production fell by 5.6% in 2023 compared to 2022.
