All currency conversions used in the creation of this report have been calculated using constant annual average 2023 exchange rates.
- The Turkish Oral Hygiene market had total revenues of \$284.8 million in 2023, representing a compound annual growth rate (CAGR) of -1.1% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 0.8% between 2018 and 2023, to reach a total of 105.8 million units in 2023.
- The performance of the market is forecast to decline even faster, with an anticipated negative CAGR of 8.3% for the five-year period 2023-2028, which is expected to drive the market to a value of \$184.3 million by the end of 2028.
