- The European Prepared Meals market had total revenues of \$41,195.9 million in 2023, representing a compound annual growth rate (CAGR) of 5.9% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 2.9% between 2018 and 2023, to reach a total of 5,457.2 million kilograms in 2023.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 5.9% for the five-year period 2023-2028, which is expected to drive the market to a value of \$54,978.0 million by the end of 2028.
