All currency conversions used in the creation of this report have been calculated using constant annual average 2023 exchange rates.
- The Japanese Prepared Meals market had total revenues of \$16,930.5 million in 2023, representing a compound annual growth rate (CAGR) of 0.7% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 3.9% between 2018 and 2023, to reach a total of 1,685 million kilograms in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 7% for the five-year period 2023-2028, which is expected to drive the market to a value of \$23,729.1 million by the end of 2028.
