- The US Prepared Meals market had total revenues of \$52,038.4 million in 2023, representing a compound annual growth rate (CAGR) of 7.1% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 4.7% between 2018 and 2023, to reach a total of 5,460.9 million kilograms in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 8.2% for the five-year period 2023-2028, which is expected to drive the market to a value of \$77,257.9 million by the end of 2028.
