- The Mexican Savory Snacks market had total revenues of \$6,266.7 million in 2023, representing a compound annual growth rate (CAGR) of 8.1% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 2.7% between 2018 and 2023, to reach a total of 811.2 million kilograms in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 7.2% for the five-year period 2023-28, which is expected to drive the market to a value of \$8,854.0 million by the end of 2028.
