The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2023 exchange rates.
- The Dutch Savory Snacks market had total revenues of \$1,306.4 million in 2023, representing a compound annual growth rate (CAGR) of 1.8% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1.3% between 2018 and 2023, to reach a total of 139.2 million kilograms in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 2.3% for the five-year period 2023-28, which is expected to drive the market to a value of \$1,466.1 million by the end of 2028.
