This performance was based on higher market sizes following spikes in demand in the wake of the Coronavirus (COVID-19) pandemic, when usage of these appliances increased in line with the higher incidence of at-home food preparation. Nonetheless, retail volume sales of all types of food preparation appliances were well below the 2019 pandemic level at the end of the review period.
