- The G8 countries contributed \$1,75,810.1 million in 2023 to the global bpo services industry, with a compound annual growth rate (CAGR) of 4.5% between 2019 and 2023. The G8 countries are expected to reach a value of \$2,01,828.4 million in 2028, with a CAGR of 2.8% over the 2023-28 period.
- Among the G8 nations, the US is the leading country in the bpo services industry, with market revenues of \$1,06,487.2 million in 2023. This was followed by Japan and the UK, with a value of \$18,639.2 and \$14,245.5 million, respectively.
- The US is expected to lead the bpo services industry in the G8 nations with a value of \$1,21,452.4 million in 2016, followed by Japan and the UK with expected values of \$19,939.5 and \$16,618.9 million, respectively.
