- Within the bpo services industry, China is the leading country among the top 5 emerging nations, with market revenues of \$34,948.2 million in 2023. This was followed by India and Brazil with a value of \$13,636.6 and \$7,166.1 million, respectively.
- China is expected to lead the bpo services industry in the top five emerging nations, with a value of \$40,727.0 million in 2028, followed by India and Brazil with expected values of \$16,689.3 and \$10,188.2 million, respectively.
