The G8 countries are expected to reach a value of \$2,228.7 billion in 2028, with a CAGR of 5.7% over the 2023-28 period.
- Among the G8 nations, the US is the leading country in the life insurance & pension industry, with market revenues of \$714.9 billion in 2023. This was followed by Japan and the UK, with a value of \$286.2 and \$236.9 billion, respectively.
- The US is expected to lead the life insurance & pension industry in the G8 nations with a value of \$1,041.4 billion in 2016, followed by Japan and the UK with expected values of \$367.4 and \$273.2 billion, respectively.
