Iron ore segment encompasses the extraction and production of iron ore from mines, which can be sold directly in the market. Coal segment includes primary coal production including anthracite, bituminous, and lignite. Base metals segment consists of lead, zinc, copper, nickel, and tin. The precious metals segment includes gold, silver, platinum, and palladium.
- All market data and forecasts are adjusted for inflation and all currency conversions used in the creation of this report have been calculated using yearly annual average exchange rates.
- The global metals & mining industry recorded revenues of \$3,506,012.4 million in 2023, representing a compound annual growth rate (CAGR) of 7.2% between 2018 and 2023.
- The production volume increased with a CAGR of 1.6% between 2018 and 2023, to reach a total of 12,969,998.3 thousand Tonnes in 2023.
- According to GlobalData, Asia-Pacific accounted for a 72.6% share of the global metal and mining industry in 2023 followed by Europe with an 11.2% share.
