The prepared meals industry within the NAFTA countries had a total market value of \$57,025.5 million in 2023. The US was the fastest growing country, with a CAGR of 8.1% over the 2019-23 period.
- Within the prepared meals industry, the US is the leading country among the NAFTA bloc, with market revenues of \$52,038.4 million in 2023. This was followed by Canada and Mexico, with a value of \$4,401.8 and \$585.3 million, respectively.
- The US is expected to lead the prepared meals industry in the NAFTA bloc, with a value of \$77,257.9 million in 2028, followed by Canada and Mexico with expected values of \$5,477.1 and \$889.3 million, respectively.
