- Within the prepared meals industry, China is the leading country among the top 5 emerging nations, with market revenues of \$8,544.5 million in 2023. This was followed by Brazil and South Africa with a value of \$1,051.7 and \$687.5 million, respectively.
- China is expected to lead the prepared meals industry in the top five emerging nations, with a value of \$11,204.0 million in 2028, followed by Brazil and South Africa with expected values of \$1,508.2 and \$1,090.4 million, respectively.
