- Within the aerospace & defense industry, Russia is the leading country among the BRIC nations with market revenues of \$34,716.9 million in 2023. This was followed by China, India and Brazil with a value of \$27,272.6, \$25,524.4, and \$2,710.4 million, respectively.
- China is expected to lead the aerospace & defense industry in the BRIC nations with a value of \$38,807.1 million in 2028, followed by Russia, India, Brazil with expected values of \$38,065.7, \$32,786.2 and \$3,438.3 million, respectively.
