The aerospace & defense industry within the NAFTA countries had a total market value of \$1,49,693.7 million in 2023.The Mexico was the fastest growing country, with a CAGR of 10% over the 2019-23 period.

Within the aerospace & defense industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,33,208.2 million in 2023. This was followed by Mexico and Canada, with a value of \$9,724.8 and \$6,760.8 million, respectively.
The US is expected to lead the aerospace & defense industry in the NAFTA bloc, with a value of \$1,41,511.3 million in 2028, followed by Mexico and Canada with expected values of \$12,513.2 and \$8,984.4 million, respectively.
