Summary

Key Highlights

- Airlines industry covers passenger air transportation, including scheduled flights but excludes air freight transport. Industry volume is defined as the total seats sold by airlines registered in a particular country or region. Industry value is defined as the total airline revenue generated from passenger traffic. It is calculated by multiplying the average revenue per passenger by the seats sold.
- The European airlines industry recorded revenues of \$332.4 billion in 2023, representing a compound annual growth rate (CAGR) of 0.7% between 2018 and 2023.
- Industry consumption volumes declined with a negative CAGR of 0.5% between 2018 and 2023, to reach a total of 18,76,752.4 thousand seats in 2023.
- According to GlobalData, the UK dominated the European airlines industry, accounting for the largest share of 17.2% in 2023, followed by Germany, capturing the second largest share of 13.8%.
