It is calculated by multiplying the average revenue per passenger by the seats sold.
- The Japanese airlines industry recorded revenues of \$38.1 billion in 2023, representing a compound annual growth rate (CAGR) of 1.8% between 2018 and 2023.
- Industry consumption volumes declined with a negative CAGR of 1.0% between 2018 and 2023, to reach a total of 121,749.3 thousand seats in 2023.
- The strong rebound in passenger demand, airline strategic initiatives, improved infrastructure, and advantageous economic conditions are all major contributors to the expansion of the airline business in Japan in 2023.
