Summary

Airlines in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2018-23, and forecast to 2028). Key Highlights

- Airlines industry covers passenger air transportation, including scheduled flights but excludes air freight transport. Industry volume is defined as the total seats sold by airlines registered in a particular country or region. Industry value is defined as the total airline revenue generated from passenger traffic. It is calculated by multiplying the average revenue per passenger by the seats sold.
- The Scandinavian airlines industry recorded revenues of \$16.7 billion in 2023, representing a negative compound annual growth rate (CAGR) of 2.7% between 2018 and 2023.
- Industry consumption volumes declined with a negative CAGR of 3.4% between 2018 and 2023, to reach a total of 114,523.4 thousand seats in 2023.
- In 2023, Denmark accounted for a 31.2% share in the Scandinavian airlines industry, making it the largest market in the region. This is followed by Norway and Sweden with a share of 26.9% and 22.7% respectively.
