It is calculated by multiplying the average revenue per passenger by the seats sold.
- The Singaporean airlines industry registered revenues of \$13.4 billion in 2023, representing a compound annual growth rate (CAGR) of 0.4% between 2018 and 2023.
- Industry consumption volumes declined with a negative CAGR of 2.1% between 2018 and 2023, to reach a total of 58,410.8 thousand seats in 2023.
- According to GlobalData, Singapore accounted for a share of 4.5% of the Asia-Pacific airlines industry, in 2023.
