It is calculated by multiplying the average revenue per passenger by the seats sold.
- The South African airlines industry registered revenues of \$3.9 billion in 2023, representing a negative compound annual growth rate (CAGR) of 2.3% between 2018 and 2023.
- Industry consumption volumes declined with a negative CAGR of 3.4% between 2018 and 2023, to reach a total of 23,161.6 thousand seats in 2023.
- According to GlobalData, South Africa accounted for a share of 0.3% of the global airlines industry, in 2023.
