It is calculated by multiplying the average revenue per passenger by the seats sold.
- The Turkish airlines industry recorded revenues of \$28,332.1 million in 2023, representing a compound annual growth rate (CAGR) of 3.8% between 2018 and 2023.
- Industry consumption volume increased with a CAGR of 0.3% between 2018 and 2023, to reach a total of 2,13,693.2 thousand seats in 2023.
- According to GlobalData, Turkey accounted for a share of 8.5% of the European airlines industry in 2023.
