- Within the automotive aftermarket industry, China is the leading country among the BRIC nations with market revenues of \$1,42,022.2 million in 2023. This was followed by Russia, India and Brazil with a value of \$42,404.8, \$24,512.5, and \$21,445.3 million, respectively.
- China is expected to lead the automotive aftermarket industry in the BRIC nations with a value of \$1,86,600.2 million in 2028, followed by Russia, India, Brazil with expected values of \$53,881.9, \$37,992.0 and \$28,729.3 million, respectively.
