All currency conversions used in the creation of this report have been calculated using constant annual average 2023 exchange rates.
- The Canadian beer and cider market had total revenues of \$15,440.8 million in 2023, representing a negative compound annual growth rate (CAGR) of 1% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 2.2% between 2018 and 2023, to reach a total of 1,915.5 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.9% for the five-year period 2023-2028, which is expected to drive the market to a value of \$19,570.5 million by the end of 2028.
