- The Chinese beer and cider market had total revenues of \$67,473.3 million in 2023, representing a compound annual growth rate (CAGR) of 0.3% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 0.9% between 2018 and 2023, to reach a total of 42,106.2 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 3% for the five-year period 2023-2028, which is expected to drive the market to a value of \$78,343.2 million by the end of 2028.
