- Market consumption volume increased with a CAGR of 1.3% between 2018 and 2023, to reach a total of 3,004.7 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 27.7% for the five-year period 2023-2028, which is expected to drive the market to a value of \$45,705.8 million by the end of 2028.
