All currency conversions used in the creation of this report have been calculated using constant annual average 2023 exchange rates.
- The Italian beer and cider market had total revenues of \$14,171.4 million in 2023, representing a negative compound annual growth rate (CAGR) of 2.1% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1.2% between 2018 and 2023, to reach a total of 2,157.9 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 2.7% for the five-year period 2023-2028, which is expected to drive the market to a value of \$16,162.1 million by the end of 2028.
