All currency conversions used in the creation of this report have been calculated using constant annual average 2023 exchange rates.
- The North American beer and cider market had total revenues of \$171,114.4 million in 2023, representing a compound annual growth rate (CAGR) of 3% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 0.3% between 2018 and 2023, to reach a total of 33,780.1 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.2% for the five-year period 2023-2028, which is expected to drive the market to a value of \$209,822.7 million by the end of 2028.
