All currency conversions used in the creation of this report have been calculated using constant annual average 2023 exchange rates.
- The Scandinavian beer and cider market had total revenues of \$10,491.9 million in 2023, representing a compound annual growth rate (CAGR) of 1.2% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 0.8% between 2018 and 2023, to reach a total of 1,636.4 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.8% for the five-year period 2023-2028, which is expected to drive the market to a value of \$12,620.3 million by the end of 2028.
