- The South African beer and cider market had total revenues of \$7,605.6 million in 2023, representing a compound annual growth rate (CAGR) of 3.8% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 4.4% between 2018 and 2023, to reach a total of 4,767.3 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5% for the five-year period 2023-2028, which is expected to drive the market to a value of \$9,726.7 million by the end of 2028.
