- The South Korean beer and cider market had total revenues of \$13,778.1 million in 2023, representing a negative compound annual growth rate (CAGR) of 2.4% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1.2% between 2018 and 2023, to reach a total of 2,301 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 1.9% for the five-year period 2023-2028, which is expected to drive the market to a value of \$15,152.9 million by the end of 2028.
