All currency conversions used in the creation of this report have been calculated using constant annual average 2023 exchange rates.
- The Spanish beer and cider market had total revenues of \$25,670.7 million in 2023, representing a compound annual growth rate (CAGR) of 4.8% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1.7% between 2018 and 2023, to reach a total of 4,522.9 million liters in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 4% for the five-year period 2023-2028, which is expected to drive the market to a value of \$31,256.5 million by the end of 2028.
