The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2023 exchange rates.

- The Asia-Pacific Carbonated Soft Drinks market had total revenues of \$82,046.8 million in 2023, representing a compound annual growth rate (CAGR) of 8.1% between 2018 and 2023.

- Market consumption volume increased with a CAGR of 4.4% between 2018 and 2023, to reach a total of 56,128.1 million liters in 2023.

- The performance of the market is forecast to decelerate, with an anticipated CAGR of 7.9% for the five-year period 2023-2028, which is expected to drive the market to a value of \$120,028.0 million by the end of 2028.
