- The European Carbonated Soft Drinks market had total revenues of \$85,874.3 million in 2023, representing a compound annual growth rate (CAGR) of 6.3% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 0.3% between 2018 and 2023, to reach a total of 45,370.8 million liters in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 5.5% for the five-year period 2023-2028, which is expected to drive the market to a value of \$112,290.1 million by the end of 2028.
