All currency conversions used in the creation of this report have been calculated using constant annual average 2023 exchange rates.
- The Mexican Carbonated Soft Drinks market had total revenues of \$27,351.6 million in 2023, representing a compound annual growth rate (CAGR) of 8.9% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 2% between 2018 and 2023, to reach a total of 22,272.9 million liters in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 5.6% for the five-year period 2023-2028, which is expected to drive the market to a value of \$35,982.5 million by the end of 2028.
