- The South African Carbonated Soft Drinks market had total revenues of \$3,888.0 million in 2023, representing negative a compound annual growth rate (CAGR) of 0.6% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1.3% between 2018 and 2023, to reach a total of 4,859.2 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.7% for the five-year period 2023-2028, which is expected to drive the market to a value of \$4,896.4 million by the end of 2028.
