- Market consumption volume increased with a CAGR of 0.3% between 2018 and 2023, to reach a total of 2,270.4 million units in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.5% for the five-year period 2023-28, which is expected to drive the market to a value of \$9,480.4 million by the end of 2028.
