- These countries contributed \$1,61,156.7 million to the global generics industry in 2023, with a compound annual growth rate (CAGR) of 12.1% between 2007 and 2011. The top 5 emerging countries are expected to reach a value of \$2,33,053.5 million in 2028, with a CAGR of 7.7% over the 2023-28 period.

Within the generics industry, China is the leading country among the top 5 emerging nations, with market revenues of \$1,21,016.7 million in 2023. This was followed by India and Brazil with a value of \$22,824.0 and \$9,214.4 million, respectively.
China is expected to lead the generics industry in the top five emerging nations, with a value of \$1,77,196.9 million in 2028, followed by India and Brazil with expected values of \$31,455.5 and \$14,400.1 million, respectively.
