- The global Carbonated Soft Drinks market had total revenues of \$360,676.4 million in 2023, representing a compound annual growth rate (CAGR) of 7.2% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1.8% between 2018 and 2023, to reach a total of 218,179.7 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 7.7% for the five-year period 2023-2028, which is expected to drive the market to a value of \$523,060.0 million by the end of 2028.
