- The life insurance segment accounted for the market's largest proportion in 2023, with total gross written premiums of \$12.8 billion, equivalent to 69.4% of the market's overall value.
- The growth in the Belgian life insurance & pension market is driven by the increasing population of individuals aged 65 and above. This demographic shift is fuelling demand for retirement savings plans and income protection policies as people seek financial security for their post-retirement years. According to Belgian, the population of individuals aged 65 and above in Belgium stood at 2.4 million in 2023, an increase of 3.3% from the previous year.
