- The Chilean life insurance & pension market recorded gross written premiums of \$7.3 billion in 2023, representing a negative compound annual growth rate (CAGR) of 3% between 2018 and 2023.

- The life insurance segment accounted for the market's largest proportion in 2023, with total gross written premiums of \$5.1 billion, equivalent to 70.8% of the market's overall value.

- In 2023, the growth in the Chilean life insurance & pension market was driven by the increasing population of individuals aged 65 and above. This demographic shift is fuelling demand for retirement savings plans and income protection policies as people seek financial security for their post-retirement years. According to the U.S. Census Bureau, the population of individuals aged 65 and above in Chile stood at 2.6 million in 2023, an increase of 4.4% from the previous year.
