- Life insurance & pension is the financial cover for a contingency linked with human life, like death, disability, accident, retirement etc. Human life is subject to risks of death and disability due to natural and accidental causes. When human life is lost or a person is disabled permanently or temporarily, there is loss of income to the household.
- The Peruvian life insurance & pension market recorded gross written premiums of \$2.9 billion in 2023, representing a compound annual growth rate (CAGR) of 8.5% between 2018 and 2023.
- The life insurance segment accounted for the market's largest proportion in 2023, with total gross written premiums of \$2 billion, equivalent to 70.1% of the market's overall value.
- The significant drop in GDP growth has created more uncertainty for consumers about their financial security. For instance, according to the Banco Central de Reserva del Peru (BCRP), the real GDP annual growth of Peru stood at negative 0.6% in 2023, as compared to 2.7% in 2022. This negative economic outlook has discouraged consumers from spending more on financial protection and retirement planning.
