- The Taiwanese life insurance & pension market recorded gross written premiums of \$54 billion in 2023, representing a negative compound annual growth rate (CAGR) of 12% between 2018 and 2023.
- The life insurance segment accounted for the market's largest proportion in 2023, with total gross written premiums of \$47.8 billion, equivalent to 88.6% of the market's overall value.
- The significant drop in GDP growth has created more uncertainty for consumers about their financial security. For instance, according to the "National Statistics, Republic of China (Taiwan)", the real GDP annual growth of Taiwan stood at 1.3% in 2023, as compared to 2.8% in 2018. This negative economic outlook has discouraged consumers from spending more on financial protection and retirement planning.
