- The Brazilian new cars market recorded revenues of \$55.8 billion in 2023, representing a negative compound annual growth rate (CAGR) of 4.6% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 4.7% between 2018 and 2023, to reach a total of 1.7 million units in 2023.
- According to GlobalData, in 2023, the revenue of the Brazilian new cars market recorded an annual growth of 9.4%. The growth is primarily driven by the increasing consumer demand for higher-end vehicles, enhanced features, and advanced technologies.
