- The Egyptian new cars market recorded revenues of \$5 billion in 2023, representing a negative compound annual growth rate (CAGR) of 12.8% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 12.9% between 2018 and 2023, to reach a total of 70,828 units in 2023.
- According to GlobalData, in 2023, the revenue of the Egyptian new cars market recorded an annual contraction of 49.4% due to the high interest rates, which impacted financing options for consumers.
