- The Kazakhstani new cars market recorded revenues of \$5.7 billion in 2023, representing a compound annual growth rate (CAGR) of 30.9% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 30.7% between 2018 and 2023 to reach a total of 184.6 thousand units in 2023.
- According to GlobalData, in 2023, the revenue of the Kazakhstani new cars market recorded an annual growth of 63.3%. The growth is primarily driven by the increasing consumer demand for higher-end vehicles, enhanced features, and advanced technologies.
